Behavioral Economic Demand for Cannabis and Tobacco among Young Adult Dual Users

This project will produce a host of novel data to understand behavioral economic demand for cannabis and tobacco among young adult dual users, which is critical to progress in preventing and treating dual use among a high-risk group. This study will produce the first prospective investigation of behavioral economic demand for cannabis and tobacco (cigarettes and/or e-cigarettes) over one year (Aim 1), the first evaluation of demand as an antecedent of dual tobacco and cannabis product use and characterization of the relative contributions of demand indices for each substance to behavioral health sequelae of use (Aim 2), and the first model testing whether demand for cannabis and tobacco mediates a link between social cognitive theory-based factors and cannabis and tobacco use (Aim 3).
